# Planters Nuts for Dad Social Sweepstakes Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: Planters Nuts for Dad Social Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age or older (or nineteen (19) years of age or older for residents of Alabama and Nebraska) and Puerto Rico who are at least twenty-one (21) years of age or older at the time of entry. #### 4. How to Enter:

Participation Requirements: To participate, you will need to have a TikTok, Twitter and/or Instagram account (each a "Social Account"). **Entry Requirements**: During the Promotion Period, take the following actions to receive one (1) entry into the Sweepstakes:

## a. TikTok:

- (1) Go to the Planter's page on TikTok and find the "Shake it Like Dad" music clip ("Music Clip")†;
- (2) While using the Music Clip, create a video that displays your dads' quirks or a father-figure in your life's quirks (video must be no longer than sixty (60) seconds);
- (3) Add a text overlay to your video that displays #nutsfordad and #sweepstakes for the duration of the video (text overlay must be legible);
- (4) Post the video on TikTok and include #nutsfordad and #sweepstakes at the beginning of your TikTok caption (your "Submission");
- (5) Your account settings must remain public during the Promotion Period and until the prizes are awarded (as described in Section 6); and
- (6) You must not change your TikTok handle during the Promotion Period and until the prizes are awarded (as described in Section 6).

†Sponsor will create, advertise and allow you to use the Music Clip in your TikTok video. Only videos on TikTok must use the Music Clip; videos on Twitter or Instagram may use the Music Clip. Use of the Music Clip will not improve your chances of winning. If a video includes any other music, it will be disqualified.

## b. Twitter and Instagram:

- (1) Tweet/post a video that displays your dads' quirks or a father-figure in your life's quirks, and include the hashtags #nutsfordad and #sweepstakes in the initial Tweet/caption (herein also "Submission");
- (2) you may optionally use the Music Clip (as described above);
- (3) Your account settings must remain public during the Promotion Period and until the prizes are awarded (as described in Section 6);
- (4) You must not change your Instagram or Twitter handle during the Promotion Period and until the prizes are awarded (as described in Section 6); and
- (5) Video must be no longer than sixty (60) seconds.

Your Submission need not include any reference, positive or negative, to Sponsor's products or services. *Including a reference/image in your social post will not improve your chances of winning.* Retweets, Instagram stories, and Instagram posts where the hashtag is included in a comment rather than the caption of the original post will not be deemed entries.

### Content Restrictions for your Social Sweepstakes Entry:

- Your Submission must be your original work;
- Your Submission must not convey any claims of Sponsor's products or services that would be deemed unsubstantiated or deceptive if made by Sponsor;
- You must have permission to include the names or likenesses of other individuals and to grant the rights set forth herein. By Tweeting/posting content that conforms to all of the above requirements, you will receive one (1) entry into the Sweepstakes. Sponsor, in its sole discretion, may disqualify any post that it finds unlawful, or in violation of these Official Rules.

Entry Limit: You may enter one (1) time during the Promotion Period. Multiple entrants are not permitted to share the same Twitter/Instagram/TikTok account. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different Twitter/Instagram/TikTok accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the Twitter/Instagram/TikTok account used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses used to create the Twitter/Instagram/TikTok account. Each potential winner may be required to show proof of being an authorized account holder. Released Parties (as defined in Section 8, below) are not responsible for lost, late, unreceived, damaged, incomplete, invalid, un-

intelligible, garbled, delayed or misdirected Submissions or failure to receive Submissions due to limitation of third-party social network platforms all of which will be void.

- **5. Sponsor's Use of Social Post Content:** Tweeting/Posting a Submission constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display such submissions in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes. If requested, entrant will sign any documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting to use the Submission.
- 6. Each potential winner will be notified through the social channel used to enter the Sweepstakes (@mrpeanut on Twitter, @mrpeanutoriginal on TikTok or @mrpeanutofficial on Instagram) and will be required to sign and return a Declaration of Compliance, Liability Waiver and, where not prohibited, a Publicity Release ("Declaration") which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim his/her/their prize. If a potential winner of any prize cannot be contacted, fails to sign and return the Declaration or provide any other requested information, within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits his/her/their prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner forfeits the prize or is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.
